

The Georgetown Labor Day Community Celebration will be Sept. 1-4, 2023 from 8:00AM-4:00PM Daily.

Please Read the rules listed below, Sign, & Return the application page, **with your full payment per your booth selection & location. Booths are from 8AM-4PM. Indoor (\$30) with table & 2 chairs (limited availability). Outside (\$25) and you provide your own table/chairs. Location is the front lawn of the Georgetown Optimist Club. You select day/or days that you want a booth Inside or Outside.** FULL PAYMENT IS EXPECTED BEFORE August 11, 2023. Make CHECKS or MONEY ORDERS to: Georgetown Optimist Club. **RETURN APPLICATION WITH PAYMENT TO: ATTN: Whistle Stop Showcase, Georgetown Optimist Club, 8260 State Road 64, Georgetown, In 47122. No refunds due to Weather or Acts of God.**

It is important that you read these rules carefully. It is your responsibility to see that these rules are obeyed.

1. Each OUTSIDE booth space is 12' wide and 12' deep. You are limited to this space since they are placed side by side. Booth contents, merchandise, and operators are required to stay within the boundaries of contracted space. (One space-12'x12', two-12'x24'). We reserve the right to refuse or reject any booth anytime for rules violation or questionable operations.
2. This event only accepting Booth rental for **non- food** booths, except cottage food is allowed per Floyd County rules & regulations. Your FULL PAYMENT for booth rental is due before August 11, 2023. NO PARTIAL PAYMENTS ARE ACCEPTED. NO CASH PAYMENTS. Make CHECKS or MONEY ORDERS out to Georgetown Optimist Club. Applications will be taken until August 11, 2023. Refunds will be made for cancellation before August 18. however, because of expenses incurred 25% of your deposit will not be returned. No refunds for booth rentals after August 18th. Your cancelled check will serve as your confirmation. Completely fill out the application form. Failure to do so may invalidate your booth reservation.
3. Booth setup is the morning of booth rental. When you arrive at the Optimist Club, a registration table with your booth information will be available, advance info will be posted on facebook event page, with Booth #'s available by Aug. 30th. All outside booths are located on the grass. Pop up tents must be weighted down, no spikes can be used. We do not have the manpower to assist you in setting up your booths or products. You are responsible for bringing your own tables and chairs. Rental of Tables may be obtained for \$10 per day, if available. Due to unloading space on pavement behind the Optimist Club. Vehicles must be moved to the general parking area when not loading or unloading.
4. All booths should be operated and occupied during the scheduled hours of 8:00AM- 4:00PM, booth area must be left clean. Vendors are responsible for the proper disposal of waste from their booth. Garbage collection bins will be provided.
5. If you are holding a drawing under the Indiana Gaming rules/regulations, it is your responsibility to apply for, obtain, and submit to Indiana Gaming for a license for drawings falling under their jurisdiction. This is your responsibility and if it is not obtained the drawing may not be held. It is the responsibility of the booth representative to supply winners of any drawing giveaways with item that was advertised.

6. All booths must visibly display name of booth, booth number, & NO SMOKING SIGN. Booth operators are required to stay within the boundaries of contracted booth space. Booth operators may not sell or distribute materials from the back of their booth or outside of their booth. Aisle ways are to be kept clear.

7. The Georgetown Labor Day Community Celebration is a family –oriented event. We do not allow materials we deem inappropriate to be displayed or sold, including guns (of any kind), or other weapons (of any kind). We do not allow shirts or objects we consider lewd or displaying offensive language or caricatures. No fart spray, silly string, invisible ink or other item that is not acceptable to the committee. We reserve the right to ask you to remove such items from your booth. Failure to comply can result in your expulsion and future banning from our event. All decisions rest with the booth Committee Directors. The following items are not allowed in booth area: alcohol, glass bottles, disruptive speakers, radios, sound systems, music, and bullhorns. In addition, no slides, posters, movies, or material that may be considered offensive will be allowed. **NO LIVE ANIMALS OR REPTILES ARE TO BE GIVEN AWAY AS PRIZES!**

ILLEGAL GOODS AND PROHIBITED ITEMS: NO ILLEGAL goods of any kind are to be sold on the Optimist Club property including the HYR park or at the Georgetown Labor Day Community Celebration. These items include but not limited to: fireworks, drugs or drug paraphernalia, alcohol for sale, no laser pointers, counterfeit merchandise and/or merchandise that infringe upon any registered trademarks or copyright laws (clothes, purses, jewelry, DVDs, etc.) Any discovery of illegal goods will be reported immediately to the proper authorities and you will be asked to leave immediately.

8. The Labor Day Directors reserve the right to assign booth locations, establish the placement of booth locations, and to refund or reject any booth any time for rules violation or questionable operations. No booth location may be sublet.

9. No vehicles of any type, are allowed in the grass (except for the designated area for the rod run). Vendors can park on the pavement behind the Optimist Club to unload for setup and load for teardown, but will need to move to the designated parking area during the event, due to the limited parking space.

10. No electrical hookups are available. Any water that is needed by you for your booth, will need to be provided by you.

11. Bathrooms are located **INSIDE** the Optimist Club.

12. The Georgetown Lions Club, Georgetown Optimist Club, or Destination Georgetown are not responsible for anything stolen or damaged.

13. **NO PETS** are allowed on the grounds unless authorized by the Labor Day Community Celebration Committee or they are a service animal with proper paperwork.
